RANDALL M. KESSLER

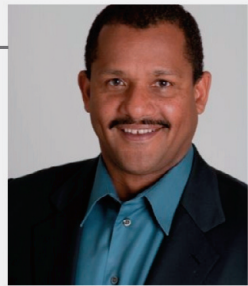
